We are inviting you to nominate children, you serve, that have open cases at the Larimer County Department of Human Services. Your nomination will serve as a chance for their dreams to become a reality. In April, National Child Abuse Awareness Month, we will be granting the wishes of children in the designated age categories. The granting of these dreams will be announced at our 13<sup>th</sup> Annual Member and Agency Appreciation Dinner at the Hilton in Fort Collins. All winning applicants will receive a formal invitation, by mail. We hope that the invitation to dream will inspire all of the children you serve to keep their dreams alive, and every child nominated, will receive a special Keeping Dreams Alive Dream Journal.

### **Nomination Process:**

We are keeping the nomination process simple all we ask is that:

1. You nominate children that have a current open case with Larimer County Dept. of Human Services
2. Nomination form must be completed by child's caseworker or recognized agency representative.
3. Nomination, Essay and Waiver need to be received by Realities For Children no later than **March 10<sup>th</sup>, 2010.**

### **'My Dream Is' Essay:**

1. The Essay should be entitled or begin with 'My Dream Is' ...
2. The Essay should be at the length of the child's comfort and ability
  - a. Essay's from younger children or those not able to write their own may be dictated to you and submitted in their words by your hand. However, regardless of age, we would like some personal submission from the child even if it is as simple as a picture of their dream
3. We would like to encourage as much creativity as possible and if a child would like to support their essay with artwork, photos, poetry or any other support pieces, it is strongly encouraged.
4. The Essay should include both the expression of their 'life dreams' and a 'tangible dream' that expresses specific hope or dream they have today that we can consider granting.
  - a. Life Dreams – When I grow up my dream is...
  - b. Tangible Dream – My dream today is to ...
